



### 2025 Driver of the Year Safety Nomination

#### One Award is Given to Each Conference

**PURPOSE:** To recognize the top driver in each motor carrier conference for their outstanding safety record and who consistently achieve excellence during their driving career.

**ELIGIBILITY:** To be eligible to compete in the WTA Driver of the Year Safety Awards program, the following criteria must be followed:

- > The nominee(s) must be employed by a WTA Member Company in good standing.
- ➤ An unlimited number of drivers can be nominated by the same Member Company.
- The driver's (safety) record should be without a blemish in the previous calendar year.
- ➤ The Member Company must submit a report for the 12-month period ending December 31, 2024, indicating mileage and total DOT recordable accidents as defined by 49 CFR PART 390.5.
- Provide all the supporting documents available.
- ➤ Information on the nominees should be complete through the 12 months ending December 31, 2024.

**JUDGING:** Judging is based on total number of years working in the industry, total number of miles driven, preventable accidents and moving violations, outstanding achievements, and humanitarian acts.
