



# 2026 Fleet Safety Nomination



## One Award is Given to Each Division

**PURPOSE:** To recognize WTA member companies for their outstanding safety and accident prevention programs in the trucking industry. This award is designed for the member carrier who consistently achieves excellence during a 12-month period of operating commercial vehicles.

**FLEET SAFETY AWARD:** Awards are given to those Member Companies who demonstrate the lowest DOT recordable accidents per million vehicle miles of operation. This award will be presented annually by the WTA and WSP to each member within each trucking division. There are two categories; one for the Member Companies who drive more than 5 million miles on an annual basis, and one for the Member Company who drive less than 5 million miles on an annual basis.

**ELIGIBILITY:** To be eligible to compete in the WTA Fleet Safety Awards program, the following criteria must be followed:

- You must operate one (1) or more vehicles in intrastate/interstate commerce.
- You must submit a report for the 12-month period ending December 31, 2025, indicating mileage and DOT recordable accidents as defined by 49 CFR PART 390.5, regardless of fault. These rules shall apply equally to all vehicles owned by the Member Company and will include vehicles provided under lease, interchange, or other arrangements.
- Winners will be determined by the following formula:  $\text{Frequency Rate} = \frac{\text{Number of DOT Recordable Accidents}}{\text{Total Vehicle Miles in the U.S. and Canada}}$

**GRAND CHAMPION FLEET AWARD:** To be eligible for WTA's Grand Champion Fleet Safety Award, companies **must** provide a short history/bio of the company and outline the company's current safety program and supervision (Max. 750 words). Additionally, CSA scores may be used as part of the review criteria in determining the Grand Champion Fleet. *Please see pages 3-5.*
